Abstract Submission Guidelines

The 3rd International Conference on Occupational and Environmental Diseases: (3rd ICOED) 15 – 17 March 2023 in Bangkok and Vicinity Areas, Thailand

We would like to invite you to submit your abstracts regarding research or other academic works related to occupational and environmental diseases. If your abstract has been accepted for presentation, the organization will only support domestic expenditures such as accommodation and traveling expenses. For a presenter residing in another country, the organization will only support accommodation while attending the meeting and the traveling expense from a Bangkok airport to the hotel. For English presentation, please follow the guidelines for the preparation as follows:

Abstract guidelines in English

1. Structure of the abstract for research and other academic developments, such as the Routine to Research (R2R) or related academic work, include:

- 1) Introduction:** Explaining the question and significance and research objective of the study
- 2) Methods:** Explaining the study design, sample selection, variables, data collection, data analysis and statistical methods
- 3) Results:** Showing important results and giving more discussion about the significant findings of a research
- 4) Discussion and Conclusions:** Summarize the main points of the study and discuss whether it corresponds to the objectives/assumptions of the research or not, or identify a problem and the influence of the findings.
- 5) Recommendations:** The suggestion about the benefit of this study or identifies issues for further research.

2. Writing an abstract

Authors must follow these guidelines for preparation. Abstracts should be made in Microsoft Word and no more than 1 page in length. The abstract should be neatly typed on A4 size (21 x 29.7 cm). The top, bottom, and right margins are required to be 1 inch (2.54 cm), but the left margin should be 1.5 inch (3.81 cm).

1) Title

The title should be typed in 14-point Bold Times New Roman font and used in capital letters for the beginning of each word.

2) Authors and Affiliations

The authors' names should include given names and surnames. They should be written in 12-point Times New Roman font. The affiliations should be written in 11-point Times New Roman font. The superscript numbers were used to indicate author affiliation and the presenting author's name underlined.

3) Abstract

The abstract should include Introduction, methods, results, Conclusion and Discussion, and Recommendation using **Bold 12-point Times New Roman font**. In addition, the content should use 12-point Times New Roman font with a single space. **The abstract in English is limited to 350 words.**

4) Keywords

3-5 key words should be applied using 12-point Times New Roman font and a capital letter for the beginning of each keyword.

5) Abbreviations

Do not use abbreviations in the title and limit their use in the abstract. Expand all abbreviations at first mention in the text.

3. Type of presentation

Do not forget to select the type of presentation:

- Oral presentation
- Poster presentation

- Ergonomics and Psychosocial Health in Workplace

5. ABSTRACT SUBMISSION

1. The submission is due on **31 January 2023, at 11.59 p.m (Bangkok Time)**.
2. The abstract must be saved in **WORD and PDF format**
3. The authors must set the subject for sending email as: **Abstract Submission 3th**
and send to E-mail: **ICOED3rd@gmail.com**
4. After successfully submitting the abstract, authors will receive an automatic confirmation by email. If you do not, please check the mail in your spam folder first, otherwise please contact:

5. All abstracts will be forwarded to the Committees for review. Announcement of abstract acceptance in <https://ddc.moph.go.th/doed> and E-mail when the process is completely done.

 - **For a presenter residing in another country, the organization will only support accommodation while attending the meeting and the traveling expense from a Bangkok airport to the hotel.**
- **The outstanding presentations (both oral and poster presentations) will be awarded and all presenters will receive a certificate for their presentations.**
- **All accepted abstracts will be published in the abstract book.**
